4:00 p.m.



The Regular Meeting of the Assumption Parish Library was held in the Olivia Chenevert Meeting Room, located at 293 Napoleon Ave, Napoleonville, LA.

President, Warren Arboneaux called the meeting to order, led the invocation and Pledge of Allegiance.

Library Board Members present were: Mr. Warren Arboneaux, President; Mr. Joe Montero, Mrs. Sandi Falcon and Mrs. Jill Johnson. Board member recorded as absent are Mr. T.J. Blanchard, vice-president; and Mrs. Anhanette Thomas. Also present were Mrs. Lenora Carter, Interim Library Director.

Mr. Warren Arboneaux stated for the record that a quorum was present so business could be conducted. He also stated that Mrs. Lenora Carter, Interim Library Director, had kept him updated on the situation concerning Hurricane Barry and he was impressed with how well she handled the situation.

- 1.) Mrs. Lenora Carter gave a brief update on the condition of all five branches following Hurricane Barry. No damage to any branches other than a few shingles lost at the Pierre Part Branch. Pierre Part and Bayou L'Ourse Branches were the only branches to lose power; both had power restored by the morning of Monday, July 15th. She also updated the board on library closures for Hurricane Barry; Napoleonville and Belle Rose Branches closed at 12:00 p.m. Friday July 12th, Pierre Part Branch was already scheduled to be closed. Bayou L'Ourse and Labadieville Branches, who are only opened half days in the afternoon were also closed Friday. Saturday closures were Napoleonville and Pierre Part Branches. All branches re-opened on Monday, July 15th, one hour later giving the staff time to clean away debris and IT time to re-boot all services. The Pierre Part Branch was without phone service until Tuesday, July 16, 2019.
- 2.) Mrs. Sandi Falcon, presented a brief update and handed out on information pertaining to property in the Bayou L'Ourse community as a possible location for a future Branch. A brief discussion was held on the next steps to be taken.
- 3.) Mr. Warren Arboneaux offered a motion, seconded by Mrs. Sandi Falcon, to postpone the approval of the minutes from the meeting of June 25, 2019, as they were not available. The motion was unanimously adopted.
- 4.) Mr. Warren Arboneaux made a call for public comment.
- 5.) Mrs. Sandi Falcon offered a motion to adjourn, seconded by Mrs. Jill Johnson. The motion was unanimously adopted. Meeting adjourned at 4:23 p.m.
- 6.) The next regularly scheduled meeting is September 18, 2019.
